Course Description The course is designed to provide the student with the knowledge and skills necessary to perform basic care services for a patient (acute care setting) or resident (long-term care setting). It prepares the student to function in the role of nursing assistant under the supervision of a registered nurse (RN). This course is designed to meet the curriculum requirements of the Maine Department of Health & Human Services.. The basic nursing assistant proficiency examination is the State-approved competency evaluation, with both written and manual skills components. The course requires the student to complete 70 hours of classroom lecture, perform 40 hours in a clinical setting, and successfully demonstrate patient/resident care nursing assistant skills (see attached Skills Listing). Satisfactory completion of the course provides eligibility to take the competency written examination for Maine state certification as a nursing assistant.

**Nature of Work** Nursing assistants perform routine duties in caring for patients or residents. Care tasks delegated by the nurse to the assistant include: transferring a patient/resident from the bed to a chair or wheelchair; walking or performing range of motion exercises; bathing, showering, shaving or providing oral hygiene for a patient/resident; feeding; changing bed linens; and maintaining cleanliness of the patient/resident's general surroundings. The nursing assistant is proficient in taking a temperature, respiratory rate, blood pressure and other patient/resident vital measurements, and reporting the results back to the nurse. The practice of good hand hygiene and patient/resident safety is expected at all times in the clinical setting.

**Course Objectives** Upon successful completion of this course, the student will be able to: Describe the organization of healthcare facilities and the roles of the interdisciplinary healthcare team. Upon course completion the student will be able to:

- 1. Maintain a proper physical and emotional patient environment.
- 2. Report and record observations.
- 3. Provide assistance in personal hygiene.
- 4. Assist with body movement and ambulation.
- 5. Assist with nutrition and elimination.
- 6. Assist with emergency situations.
- 7. Assist the RN in providing general patient care.
- 8. Communicate in an effective and positive manner.
- 9. Demonstrate understanding of skills appropriate for the CNA

<u>Qualifications</u> Must be 16 years of age. High school diploma recommended. Satisfactory criminal background check. Demonstration of logistical, metacognitive (organizing and planning) skills and support to be successful in the course. CASAS Assessment Goals Reading Score of 235. CASAS Assessment Goals Math is also recommended. #### **Contact Information Instructor:**

Course Format Classroom/Lab components of this course are hybrid with live classroom time scheduled Monday, Tuesday and Wednesday afternoons from 5pm-8:30pm with a 30 minute break. In addition at least 4.5 hours of asynchronistic instruction during each week. The course is divided into ten units. Units will open weekly on Thursday for the following week. (see the attached schedule). There are two potential scenarios being explored about meeting clinical requirements that are not 100% clear due to the pandemic. The preferred scenario is 70 hours of clinicals at the end of term at Northern Light Maine Coast Hospital and area nursing and rehabilitation facilities. Alternately, depending on the pandemic situation, all the skills demonstration will happen in a lab set up, that state registry exam will be taken by CNA candidates and upon hiring a nursing supervisor at the facility where you work will document the 70 hours of successful work on the floor.

Nursing Assistant Lab & Clinical Experience Students are required to participate in 20 hours of lab time and 40 hours of clinical time. These experiences provide the opportunity to practice and demonstrate mastery of 175 discrete skills in areas listed below. It is the responsibility of the learner to be proactive during these sessions to work with the instructor and clinical site personnel to ensure they have the opportunity to demonstrate mastery of the skills.
